## **Information I Collect**

#### **Disclosure of Information**

I may not use or disclose the information provided by you, except under the following circumstances:

- As necessary to provide services or products you have explicitly ordered or requested.
- In other ways described in this Policy, or to which you have otherwise consented.
- In the aggregate with other info, in such a way so that your identity cannot be reasonably determined.
- As required by law, or in response to a subpoena or search warrant.
- To legal outside auditors (such as insurance carriers) who also keep information confidential in accordance with the law.
- As necessary to enforce terms of service and applicable law.
- As necessary to maintain, safeguard & preserve the rights and property of Glenn M. Page.
- If a person completes a submission form via my Medicare website, or Medicare ad, that constitutes permission to contact under CMS guidelines. You may revoke permission at any time via email, text, or call. Simply state: "I revoke permission to contact".
